I. Statement on the Change of the Company's Stock Name

Haier Smart Home Co., Ltd. (hereinafter referred to as the "Company", formerly known as "Qingdao Haier Co., Ltd.") convened the 28th meeting of the ninth session of the Board on 5 June 2019, and reviewed and passed the *Proposal on the Proposed Change of the Company's Stock Name of Qingdao Haier Co., Ltd.*, which intends to change the Company's stock name to "Haier Smart Home", and the stock code remains the same as "600690".

II. Reasons for Change of the Company's Stock Name

In order to better demonstrate the globalization development of the Company and promote the implementation of IoT ecological smart home brand strategy of the Company, the full name of the Company has changed from "Qingdao Haier Co., Ltd." to "Haier Smart Home Co., Ltd." on 20 June 2019 as approved by the 28th meeting of the ninth session of the Board and the 2018 Annual General Meeting of the Company and in accordance with the business license issued by Qingdao Administration for Market Regulation. For establishing unified image identity and further improving the Company's external image and distinctiveness, and as applied by the Company and approved by Shanghai Stock Exchange, with effect on 1 July 2019, the stock name of the Company changes from "Qingdao Haier" to "Haier Smart Home", and the stock code remains the same as "600690"; the Convertible Bond Name "Haier Convertible Bonds" and Convertible Bond Code "110049", as well as the Convertible Stock Name "Haier Convertible Stocks" and Convertible Stock Code "190049" remain unchanged.
